

- 2) Application form addressed to The **Head of Microbiology Department, Medical College Baroda** (As per the prescribed Performa) along with self attested copies of certificates of educational qualifications, research publications and experience certificate, identity proof, and two photographs is to be **submitted at the HOD’s office of Microbiology department- inward section, Medical College Baroda, Vadodara.** Applications received after the last date will not be considered.
- 3) It is the sole responsibility of the candidate to see to it that his/her application has reached at Department of Microbiology, Medical College Baroda, Vadodara. Institute is not responsible for any postal delay.
- 4) Canvassing in anyway will lead to disqualification of the concerned candidate.
- 5) Candidate should possess required educational qualifications and/ or experience required for the post.
- 6) The Head of the department and the Dean will review the work of candidates appointed on the contract basis. If the review is unsatisfactory, the Dean reserves the right to terminate the appointment of a candidate without any prior notice.
- 7) Appointed candidate has to work full time under control of the Head, Department of Microbiology and the Dean, Medical College Baroda, Vadodara.
- 8) The appointment will be purely on the contractual basis. The candidate has no right to claim for the regular appointment. Selected candidate will not be eligible for any benefits of the permanent employees or any teaching experience.
- 9) The selected candidates for the post have to submit an undertaking regarding acceptance of rules and regulations on a Rs. 300 stamp paper duly notarized by an authorized notary. The candidate will also have to submit an undertaking on Rs. 300 stamp paper stating that he/she will not approach the Hon. Court for regularization of his/her service on the basis of the order issued for the above postor discontinuation of service.
- 10) Appointments will be given as per rules and regulation of the concerned authority. The candidate with higher qualification and experience will be preferred.
- 11) The candidates must possess a working knowledge on computer knowledge. Possessing CCC/CCC+ certificate is desirable.

If necessary, a written examination will be conducted and the candidates qualifying the written test will only be interviewed.
