NOW THE CONDITIONS OF THE ABOVE WRITTEN BOND ARE THAT.

- (i) The student shall diligently pursue and complete the MBBS course at the said college in the state of Gujarat and strictly comply with the rules of the said college. If the student is granted migration / transfer from one college to another college at the end of the 1st year examination shall have to follow the rules of the college where the student has been migrated / transferred and shall have to attend the college regularly and shall complete the course passing the prescribed university examination and internship.
- (ii) After passing the said examination and undergoing internship for such period and at such institution as may be prescribed, the student shall within a period of 30 days, inform to the Commissioner of Health, Medical Services, Medical Education and Research (hereinafter referred to as COH) to offer himself for the Government/Rural Services and if the student is called upon by the Government or COH, the student shall serve the Government / District Panchayat / Local Authority for one year in such grade and remuneration as may be prescribed by Government.
- (iii) During the period of rural services, the student shall be required to serve under the provision of the bond, discharge the duties faithfully assigned to him/her and observe the rules for the time being in force regulating the conduct.
